ORDER

- 1. Provisional affiliation was granted, vide U.O. read as 1st, for starting B.Ed degree programme at Holy Family College of Education for Women, Koduvayoor, Palakkad during the academic year 1995-96 with an intake of 100 students. The optional subject Natural Science was included in the B.Ed programme with an intake of 16 students without change in the total intake, vide U.O. read as 2nd.
- per the NCTE Regulations 2014, vide paper read as 3rd above, B.Ed programme shall be of having a duration of academic years, and the intake shall be with a basic unit of 50 students with a maximum of two units.
- 3. The NCTE has permitted the college for conducting B.Ed programme of two years duration with an annual intake of 100, for two basic units of 50 students each from the academic session 2015-16 vide letter read as 4th.
- 4. As per the U.O. read as 5th above, the Syndicate has resolved to grant Continuation of Provisional Affiliation to Teacher Education Colleges as usual in the beginning of the academic year as in the case of other programmes, without insisting extension of the approval from NCTE.
- 5. As per the U.O. read as 7th above, revised seat distribution in B.Ed. programme w.e.f. the academic year 2020-21 was sanctioned along with rearrangement of seats for the academic year 2020-21 at various colleges in Palakkad. & Wayanad Districts.
- 6. Continuation of Provisional Affiliation was granted to B.Ed programme at Holy Family College of Education for Women, Koduvayur, Palakkad with an Intake of 100 students for the academic year 2020-21 vide U.O. read as 9th.
- 7. The Principal, Holy Family College of Education for Women, Koduvayoor, Palakkad vide letter read as 10th, has requested to grant Continuation of Provisional Affiliation to B.Ed degree programme for the academic year 2021-22 along with an affidavit and an approved stafflist which are insisted in the Circular read as 8th above. The Principal has remitted an amount of ₹1,54,350/- (Rupess One Lakh Flfty Four Thousand Three Hundred and Flfty only) towards administration and affiliation fee vide Chalan No.202210158 dated 04.12.2020.
- 8. As per U.O. and Circular read as 6th and 8th, periodical renewal of No Objection Certificate(NOC) from Government

for Issuing orders granting Continuation of Provisional Affiliation in respect of programmes sanctioned to signs based on the NOC issued by the Govt.

pepartment of Higher Education, Govt. of Kerala, has renewed the NOC for conducting self financing 8.50 programme in Holy Family College of Education for Women, Koduvayoor, Palakkad for the academic year 2021/22, vide G.O. read as 11th above.

10. Sanction has, therefore, been accorded by the Vice Chancellor, on 07/06/2021, for granting Continuation of Provisional Affiliation to the B.Ed programme at Holy Family College of Education for Women, Koduvayoor, Palakkad (Un-aided) for the academic year 2021-22 with optional subjects and intake as noted below and subject to the terms and conditions specified thereunder.

- 11. Affiliation granted is strictly provisional and only for the academic year 2021-22. The College has to apply for Continuation of Provisional Affiliation for the ensuing academic years, remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 12. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued from time to time, failing which the affiliation granted will automatically be cancelled.
- 13. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- 14. The list of colleges which have renewed their provisional affiliation will be forwarded to the Office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.
- the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures of prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the College will be initiated.
